Qualifications

- Must be a student member of the American Dental Hygienists' Association
- Must be in good standing in a Nebraska dental hygiene program and have written approval from the program director
- Must be a second year dental hygiene student
- Must be available for all NDHA meetings(In person, virtual or conference call)

Application Process

Students interested in applying for the Student Liaison position must submit the following items:

- Application
- Program Director Verification Form
- A typed essay of 250 words or less, written independently of any external assistance

*Incomplete applications will not be considered. Completed applications are due to the NDHA Awards Chair by **August 28, 2017**.

Duties

Duties of the NDHA student liaison include but are not limited to:

- becoming familiar with the NDHA Procedure Manual and Strategic Plan
- be in attendance at all NDHA meetings and engage in discussions
- maintaining confidentiality of all private documents and discussions
